# What is required to use this service?

- You will need an address listed as being nbn<sup>TM</sup> ready
- You will need an nbn<sup>TM</sup> capable modem/router to access the service. In some cases nbn<sup>TM</sup> may need to install equipment at your premises, in some cases, a power point will be required and you will need to have approval from the building owner for the works to be completed.
- If the premises are in a multi-dwelling building nbn<sup>TM</sup> may require access to common areas such as the MDF
- You must have a suitable earth point as well a power outlet installed where you intend to have the NBN NTD installed.
